# Attending the meeting and proxy voting

### Attending the meeting

Only holders of American depositary shares (ADS) who were ADS holders on the US record date Monday, **March 18, 2024** (the US Record Date), are eligible to attend the meeting and to exercise voting rights (via JPMorgan).

Any ADS holder who wishes to attend the meeting in the Netherlands should contact the JPMorgan Service Centre on +1 800 990 1135 (from the US) or +1 651 453 2128 (from outside the US) no later than Friday, **April 12, 2024**, 9 a.m. (EST). An ADS holder will be entitled to attend the meeting if that person held ADSs on the US Record Date.

### Proxy voting

Registered ADS holders as of Monday, **March 18, 2024**, are asked to complete and return the distributed proxy card to the depositary by the time and date stated on it. A prepaid envelope is supplied for this purpose.

ADS holders are requested to contact the JPMorgan Service Centre at +1 800 990 1135 (from the US) or +1 651 453 2128 (from outside the US) for further assistance.

Those ADS holders not holding via JPMorgan in nominee form are asked to contact their Custodian Bank or Broker to exercise their voting rights.
